- John Nunn presented a proposed "Code of Conduct" for LBRA members. See Action Item 27.
- Marine Safety Officers from the Marine Stadium Rescue Boat 3 Station gave details about the planned closing of their Marine Stadium Station. They asked for the Rowing Association's support to forestall that closing. The officers indicated the next closest rescue boat is located 13 and a half minutes away should an emergency arise. The John Nunn said we had saved money of having to install a sprinkler system during our remodel because of the fact that we shared the building with a fire station. A motion passed to pay an amount not to exceed \$500 for an advertisement in a local paper to indicate LBRA's support for the Fire Station remaining open. Support for the Rescue Boat 3 Station can be shown Tuesday at 3:00 PM at the City Council meeting at City Hall.
- Jack Nunn proposed additional classes for Rowbics. It was agreed these would be acceptable after Summer Camp on Tuesdays and Thursdays from 10:15 to 11:15 AM.
