MINUTES OF THE BOARD OF DIRECTORS April 6, 2011

The meeting was called to order by the President at 7:40pm and minutes of the March 2011 board meeting were read and approved.

President's Report

- With respect to the one bounced check from the Beach Sprints, Rob Johnson put a stop payment on his check when he realized he could not attend the race. He told Jim that he will send LBRA another check for the \$10 bad check fee the club incurred.
- The club had \$5278 income from the wind-shortened Spring Regatta. Katrin Gleie will make a more thorough accounting for the next meeting. Kristina Dugan passed out list of suggestions for improving next spring regatta and other club regattas.
- Jim Litzinger had sent Victoria Draper a letter of suspension arising from her use of the club's erg room to conduct a class. Jim turned the floor over to Victoria to explain this incident. Victoria stated that Concept 2 scheduled her to run the workshop/class, and that she has little control over this scheduling. Having requested to use space at LBRA and the Warehouse, and having been refused in both cases, Victoria attempted to cancel the workshop with the client, but the client was in transit and could not be reached. As the client and his spouse had travelled a fair distance (Alaska), Victoria thought that at the very least she could meet him at LBRA and show him how to row on the dock machines but she did end up using the ergs. John Van Blom made motion, to chalk the matter off

reinstate Victoria's membership. Dan McGill seconded the motion and it was unanimously approved.

Treasurer's Report

- Katrin Gleie reported that the final accounting for the Beach Sprints is in and only one check bounced – Robby M Johnson. Jim Litzinger is willing phone him on the matter. Katarin turned over to John Nunn the cancelled checks for the lighting project. AC will also find and turn over cancelled checks for the 10N and bathroom repairs, estimated at \$2K.
- Katrin turned the floor over to MK Kuner and Rita Vanlierop to report on the budgeting project. Drawing on 15 moths of P&L statements, MK and Rita have constructed a spreadsheet for budget projections. A copy of the spreadsheet is appended in the paper records. To complete the project, MK andRita will go over some minor issues with Katrin, and discuss insurance with AC as well as other large dollar items he's been handling.

Captain's Report

- Six boats belonging to members in arrears were moved to the Powerhouse warehouse. Some will be sold eventually, and others will be held till owners pay something. This freed up rack space for some singles and made others accessible.
- Juniors coaches must emphasize tying down boats stored outside several blew down in the windstorm last weekend. Adaptive program also had boats blow down in the storm. As the adaptive program has decreased in size, some of their boats should be moved. The old Archer is wanted by Denver, so it will be transfer at the Crew Classic.
- The issue of tree trimming still pending with city. Brandin Grams and AC fixed sound system in erg/weight room so that both rooms have sound with speakers in the ceiling. This system is much, much better and many thanks to Brandin. The shop has frequently been left open with many specialized tools taken out from the rollaway. Therefore a punch pad key system and aluminum strip was recently put in place.

New Business

- Jim Litzinger stated that the LBJC juniors have been rowing the LBRA Fillipi doubles without AC's permission. AC and Jim both affirmed that LBJC juniors should take LBJC boats if they are there, rather than the club's Filippi's. [These statements were directed at Keith Johnson and Filip Reinis, of LBJC's board, and they acknowledged this.]
- The trailer will be loaded this weekend for races. The CSULB crew has requested use of two LBRA catamarans for their opening day regatta. One

LBRA launch will be left for coaching that day. The catamarans need some work, therefore need drivers should pump out pontoons before leaving the dock.

- In searching for a boat to replace the Wintech 4X, AC, Larry and Dan McGill have seen a Sykes 4X (1yr old) which could be rented or acquired on a rent to own basis. They've also found a lightweight Pocock 4+ that might also be a good possibility. The contract terms for the Sykes need to be examined by Andrea or Katrin to really understand how much the club would be paying. Wintech will be put on row2k this month with proceeds to go toward a new boat.
- Brandin Grams of CSULB crew stated that SoCal Opening Day is this weekend, with racing from 8am to 11am. The stadium reserved until noon. Brandin has met with Kim Marie of the city to have all permits and other issues squared away with city departments. All equipment and personnel to run the regatta are set to go. Five schools will race. Some moored boats will be moved to allow racing in lanes 1 and 2 next to Naples. The college will post traffic patterns and warnings at boathouse. They appear to have enough marshalls, but all crews rowing that day should be cautious. Trailers will arrive Friday night, all parking on the beach side of the stadium.
- The juniors made detachable shades for the erg room windows. These will be stored in the erg room under the trophy shelf.

The meeding was adjourned at 8:30pm.
