MINUTES OF THE GENERAL MEMBERSHIP ANNUAL MEETING October 8, 2014

The annual general membership meeting was opened by the club's president, Jim Litzinger, at 7:30 pm. Jim welcomed the many new members in attendance and invited all members in attendance to introduce themselves. After introductions, Jim thanked last year's board and directors, Dara Lampe (the membership chair), members of the coaching committee, the club's hospitality committee.

In reviewing the year, Jim reported that Learn to Row Day was a huge success, with over eighty new members joining as a result of this event. Jim thanked the club's coaches, Anna Leiberovsky, Carlos Recharte, Katrin Gleie, and Sherri Kline, who help the entire membership improve. Recognizing that a growing membership needs boats to row, the club purchased several boats (two lightweight women's 8+'s, a heavyweight men's 2X/2-, several novice singles, and several sets of oars) with the increased dues income.

Looking forward to the coming year, the City has plans to rebuild 3S, the finish line structure. The new head of the Marine Bureau has sent the project out to bid. The key fob system will be upgraded this year; the system data base will be wiped clean, old fobs will be collected and new fobs mailed out. The Christmas Regatta is fast approaching (December 7) and Jim closed his remarks by calling for volunteers to work the race

Rob Perrot of the Nominating Committee took over the floor and called for volunteers for Audit Committee. Scott Renner and Robert Linden responded and will be the Audit Committee for the coming year. On asking for nominees for the Nominating Committee, Rob Perrot, Elna Anderson, and Jerry Costello were nominated from the floor and accepted.

The candidates for director spoke (Jill Ammirato, Andi Parsons, Steve Chaffee, Bryan Bayer) save Ken Mattfeld who was ill and not in attendance. Officer candidates were all unopposed but each spoke on why they would like to continue in their offices (save AC who was loading the trailer). Then, with all ballots collected, the Audit Committee retired to count the ballots.

MINUTES OF THE LBRA BOARD MEETING October 8, 2014

The first meeting of the new board commenced at 8:50pm. The president asked for a \$400/month stipend for the Treasurer, which the board approved by consensus. With respect to the summer cleaning and maintenance invoices to LBJC, Jim stated he had agreement from LBJC's president, Keith Johnson, to split maintenance costs 50/50 of

maintenance and to have LBJC pay 2/3 of cleaning. Subsequently, LBJC sent a check only for 1/3 of cleaning and 50% of the janitorial supplies. Jim will talk to Johnson again tomorrow to straighten LBJC out and remind Johnson of the agreements in their previous conversation.

With respect to new equipment, AC duPont will look at launches while in Boston. The club plans to purchase four new launches, sell the current Wintechs and abandon the pontoon design from parts in the storage yard.

The Treasurer spoke on several billing issues with LBJC. The Junior's board wants extensive documentation on the erg maintenance fee and building maintenance fee; minutia ranging from monitor serial numbers and chains, logs of AC's time, and receipts for all batteries. Jim stated that each club pays about \$2000/yr to use ergs. Jim stated that the previous treasurer (A. Arriola) had not bill appropriately in the past couple years, so Juniors did not pay for erg maintenance specifically last year, where the prior treasurer (S. Aris) did bill LBJC for erg maintenance and they had paid.

The property tax bill is another area of contention with LBJC. The Juniors claim to have been paying property taxes for the past several years. LBRA has also been paying property taxes, which Jeannette will verify in the records. The State has more recently levied higher property taxes on the club. John Nunn will determine what parcel number is on Junior's tax bill which will be compared with the parcel number on LBRA's bill.

Lastly Jeannette has reimbursed club members for Bay series expenses and paid the trailer insurance bill.
