Meeting was called to order by the president at 7:40 p.m. Minutes from the June 3rd meeting were approved with two corrections.

Presidents Report

- Jim Litzinger reported that LBRA Member Earl Johnson has petitioned to conduct his annual Luau on Saturday August 1st.
- A.C. duPont to depart for Lake Merit in Oakland Area to deliver shells for Regional Masters Regatta this weekend.
- Jim Litzinger appointed John Nunn and John Callos as committee to contact Parsons Engineering Company of Pasadena and the custodians of the Tidelands Oil Funds to explore either or both to help resolve LBRA's obligation to the three mortgage holders (John Nunn, Earl Johnson and Boris Beljak) who hold notes for \$90,000 combined.

Boat Captain's Report

- Boat Captain A.C. DuPont reported that we have run out of keys. He is in the process of ordering additional keys.
- He has requested the need for better discipline with rowing shells, particularly from the Junior rowers. Historically, the young rowers have always required more training with regard to handling their shells because they are new to rowing and require learning how the system works best. The coaches have always been a key to this problem.
- John Van Blom agreed with duPont and gave examples of the protocols in the staging area.
- A.C. duPont displayed an American Flag which was flown in the battle areas of Iraq by one of our members. He wants to frame a letter from the front and display the flag. He has asked John Callos to find a traditional triangle case for the flag or to build one himself.
- Keith Johnson, President of the Junior Board of Directors, reported he has found lights left on in chase boats resulting in dead batteries.
- Discussion led by duPont relative to new oars.

- Liza Luna gave a presentation of the newly updated LBRA Website.
- Jim Litzinger commented on the terrific results turned in by the Juniors in the recent nationals regatta. He, duPont, Van Blom and Nunn each commented on the outstanding job the Juniors have done since their recent reorganization.
