The meeting was called to order by the President at 7:45 p.m. After discussions about the capability of the website to provide separate secure sub-sites so that the secretary could post approved minutes directly to the website without going through an intermediary, John Nunn moved that the minutes be approved with corrections. The motion was seconded and approved.

## President's Report

- President Jim Litzinger said the website is still being worked. There was a
  discussion about challenges in finding members in the website because
  members' names are listed on pages that are accessed by links that are
  numbered instead of by links identified by letters of the alphabet.
- Jim indicated that per the Board's approval at the last meeting additional cameras are being placed in the bays, with two in the Junior Bay. No cameras are being placed in the college bays at this time.
- Jim is in the process of getting estimates for new lighting that would be energy saving, have less interference with boats stored in upper racks, and would have infrared and timer on/off switches. The costs would be around \$11,000 for the bays and \$1100 for each bathroom. Jim is going to talk to the City Liaison Officer about funding this lighting.

- On November 11<sup>th</sup> a \$1000 check was received from Rowbics and so classes were allowed to continue through November. A check for \$790 was received on the day of our Board Meeting to repay some of the past due money from Rowbics and to allow Rowbics to continue with its boathouse classes through December 31<sup>st</sup>.
- A motion was created by multiple Board members to select Junio & Taylor to get our book keeping in order and to take care of our past, current, and future state and federal tax filings at the rate of \$600 per year for the years 2004, 2005, 2006, 2007, and 2008. The motion was seconded and passed. An action was generated for Jim Litzinger to furnish Andrea Arriola with the tax information we do have by December 12<sup>th</sup>.
