# MINUTES OF THE BOARD OF DIRECTORS November 7, 2012

The open meeting was called to order by the President at 7:35pm and minutes of the October 2012 meeting were read and approved.

#### **President's Report**

With respect to removal of LBJC property from 10N, Jim Litzinger stated that the building seems fairly well cleared out. Litzinger and Nunn will meet with City representatives on Saturday to discuss what might be done in the remodel.

In advance of the Christmas regatta, Kristina Duggan will send out this week an email blast to the membership for volunteers and to request t-shirt designs. Jim will also ask Ken Plumb to submit a design. The preliminary regatta schedule is posted on the website. Renn Levy asked Jim to be sure that food for regatta volunteers (including the morning) be lined up. Renn also requested that volunteers who are parents be allowed to bring their children along to their assignment, within the bounds of safety concerns. Jim agreed to this.

Jim reported that the Fundraising Committee (Jill G., Andrea, Sherri and Jack) is considering possible events, and he asked Andrea Arriola to give them specific guidelines to be in compliance with tax codes and good accounting practices. The committee also needs to discuss with the ERG to what purposes the funds should be disbursed; Andrea will contact ERG coach Ian Simpson on this matter.

#### **Treasurer's Report**

Andrea Arriola reported that Powerhouse Fitness and LBJC are current. Membership dues, however, are \$2.7K lower than the same time last year. Andrea will ask the Membership Chair for an updated member list.

#### **Captain's Report**

The two new boat covers used to transport the Nemesis 8+ and Empacher 2X to the Head of the Charles were fantastic. More covers are on order for other club boats. A.C. repaired the purple Peinert damaged in a collision with a lifeguard boat; this single is now back in service. All the club's Peinert singles have proven incredibly sturdy. After continuous use for several years, all are still great. One launch still has some steering problems, but all launches (3 cats, 1 large whaler and 1 small whaler) are in good shape for the Christmas regatta. A.C. switched out the tubing on the doubles rolling rack – square tubing holds the boats more securely.

On trips to the fall regattas, A.C. purchased parts from Vespoli and Empacher, and he picked up a kidsize single (for free) for the kids of club members to try. Parents must be on water with their child, therefore only rowing parents are allowed to take out this boat.

AC asked whether any changes could be made in planning for the dock rebuild. Nunn has the City's engineers to plan a structure that will fit more boats at once than the current dock.

Adressing the LBJC board members present, AC stated that he had made a huge effort to bring get the remaining LBJC 8+ (which they had left behind) to NARF. A.C wanted LBJC to realize that LBRA does go out of their way to help them.

#### **New Business**

- The Masters' Coaching Committee chair, Rob Glidden, handed out a report and proposal from the committee (copy in permanent records) Rob asked for board approval to send out asurvey to members to gauge demand for coaching. The committee will then ask what coaches want to do (as far as groups they want to coach), research coaching organization at other clubs, and work out with the board the power of the committee. Rob asked permission to send an email blast to the membership with a link to SurveyMonkey. Nunn motion that the coaching email survey in the proposal go out to all members. Jill Gresham seconded the motion which passed unanimously. Rob Glidden and the committee will come back to board with results of the survey at the December meeting.
- Vaughn Sherman displayed samples of the college logo sweats that Patty Sherman proposed to sell at the Beach Sprints as a fundraiser for the ERG. The clothing will be donated for the event and the goods will be displayed on racks outside the rowing center.
- Jim tasked the LBJC board members to relay to their coaches, members and parents that trash from Thurs evening dinners needs to be taken outside.

The meeting was adjourned at 8:47pm.
